No Shiny, sparkly blankets. Flexi-leads are not to be used where dogs are running.

ELIGIBLE BREEDS & REGISTRY:

Only purebred Silken Windhounds.

“All entries in the regular stakes shall be individually registered with the American Kennel Club, the National Greyhound Association (NGA), including the United Kennel Club (UKC), the Federation Cynologique Internationale, an ASFA-recognized foreign or ASFA Board approved registry or possess a critique registration number (CRN) from the Society for the Perpetuation of Desert Bred Salukis (SPDBS). Provisional stake entries shall be individually registered with the appropriate registry. (Dogs with an Indefinite Listing Privilege (ILP) or Purebred Alternate Listing (PAL) from the American Kennel Club shall be considered registered with that body.)”

AWARDS FOR TRIAL

Awards will be offered for Best of Breed

Ribbons or rosettes will offered for all placements.

**First=Blue, Second=Red, Third=Yellow, Fourth=White, NBQ=Green
Highest Scoring Single=Navy/Gold, Best of Breed=Purple/Gold**

REGULAR STAKES OFFERED

OPEN STAKE: Any Silken Windhound, excluding ASFA Field Champions of record that has met the certification requirements.

FIELD CHAMPION STAKE: Any Silken Windhound ASFA Field Champion

VETERAN STAKE: Any Silken Windhound whose age is at least six years. That has obtained an ASFA certification, AKC QC, or other qualifying waivers prior to the closing date. A copy of the certificate **MUST** be submitted with the entry forms. Points go toward V-FCh or V-LCM titles.

SINGLES STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed. Hounds are eligible to earn TCP and CPX titles from the Singles stake.

*****No Best In Field Will be Offered*****

Note: Hounds who have received a disqualification at an ASFA trial are ineligible to compete until reinstated.

RULES & INFORMATION:

All entries must be one year or older on the day of the trial. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter except in the Single Stake. Hounds not present at the time of roll call will be scratched. All hounds will run twice, in trios if possible or braces, (except in the Single Stake and LCI), unless excused, dismissed or disqualified.

There will be a \$10 fine assessed for any loose hound not taking part in a course in progress.

Persons exhibiting conduct detrimental to ASFA/ORCA/any hound(s)/other person(s) will be asked to leave the trial site.

This applies to hounds entering Open, Veterans, Singles, or Provisional for the first time.

Muzzles are not required; it is the owner's responsibility to determine if their hound should be muzzled. But muzzles are allowed.

PET VACCINATIONS

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Rabies vaccination should be current, as required for the state you live in.

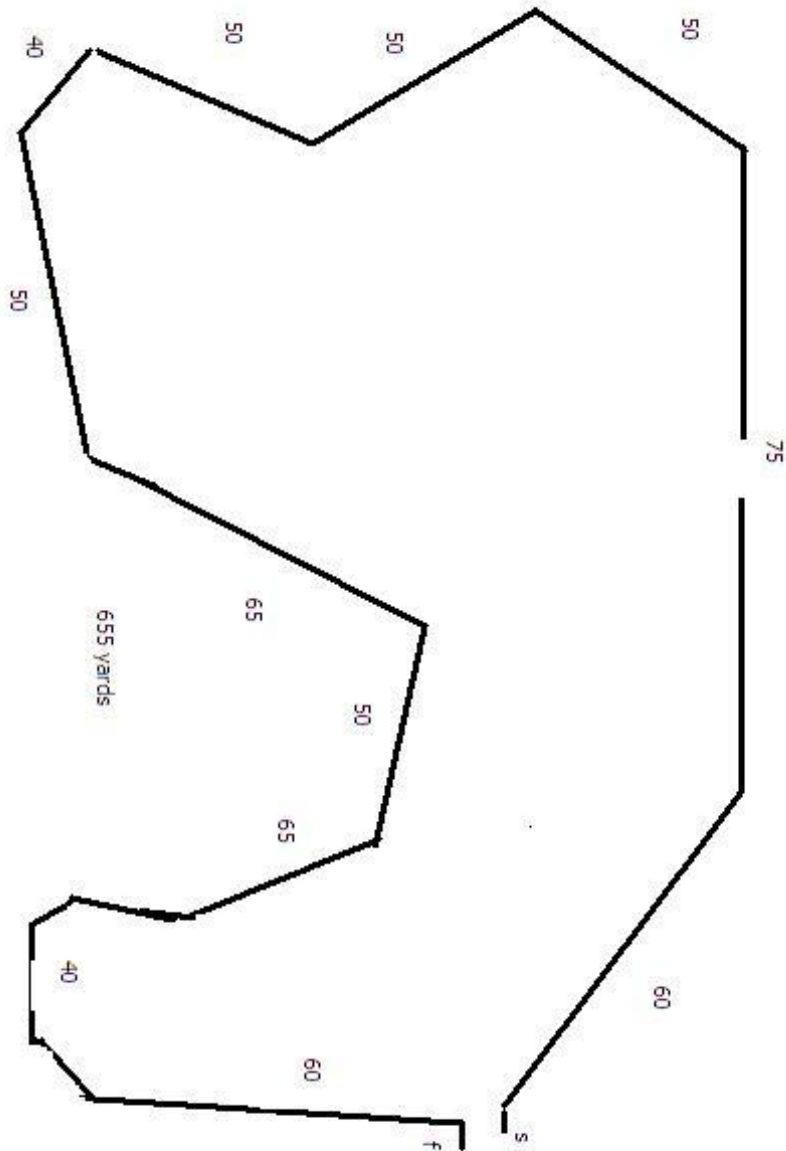

Saturday field course design.

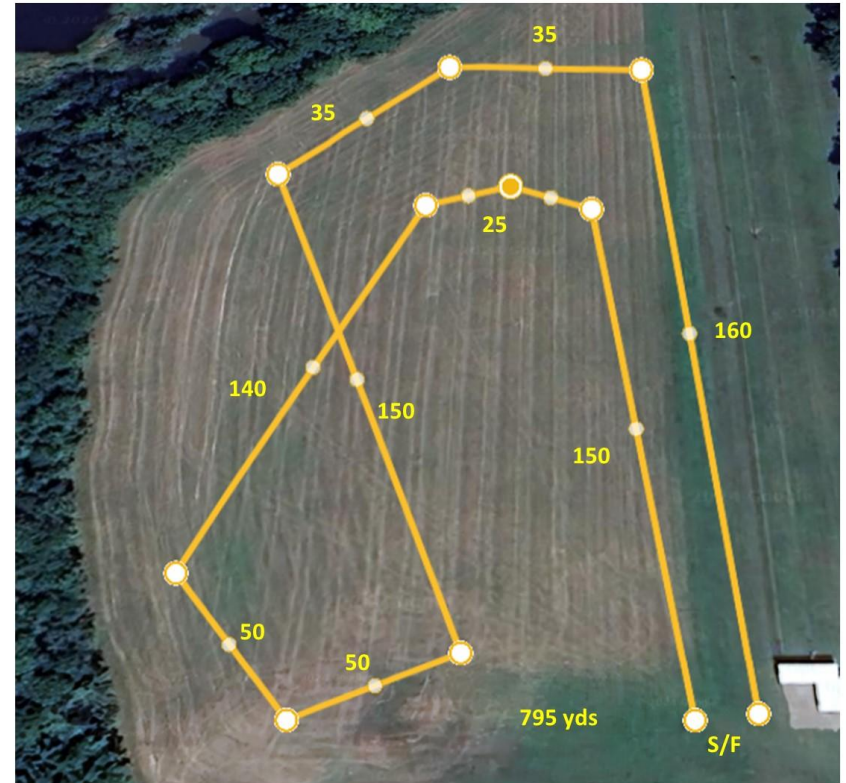
