

REFUNDS:

This is an AKC Event. Like other events, i.e. agility, obedience, conformation, etc., refunds will not be issued if a dog is pulled or entries are canceled before or during the event. Refunds will only be issued for lame or in season dogs. If the event is canceled, it will be at the discretion of the club whether entries will be refunded or not.

TRIAL HOURS

8 am until completion.

Two tests will run simultaneously with first and second test run for each group of 10 dogs.

Workers dogs may be inspected and run earlier than trial dogs.

INSPECTION:

All dogs will be inspected for soundness prior to running each event. All bitches will be checked for being in season prior to running each event. Per AKC Rules: No wrappings or blankets can be on the dog when being inspected. The inspection committee has the right to decline a dog if they feel it is too overweight or unfit to compete.

As soon as dogs have run test 1, they must present for reinspection before running test 2.

Brachycephalic and heavy coated breeds will run first to get them out of the heat.

*****NOTE: If a dog is unable to be inspected by the inspection committee, it will be excused, and a refund issued. If a dog demonstrates aggression towards people, you will be excused, and receive a refund. This is a no tolerance policy. An aggressive dog report MAY be filed with AKC in this event, and you could receive a suspension from all AKC activities. *****

*****If your dog is people aggressive or overly dog aggressive, do not bring it to this event. ****



RIBBONS:

A light blue flat ribbon will be given for each qualifying FastCAT run.

A new title rosette will be available for dogs who have earned a new AKC title at this event.

STAKES OFFERED:

Fast Coursing Ability Test (Fast CAT).

Open to all dogs, including mixed breeds/all American dogs that are registered with AKC's Canine Partners. Dogs must be at least one year old to compete.

The field is on a country road and there is no physical address.

From I-44 -- Take the Big Cabin exit, go north on Hwy 69 to Hwy 60, then go left (west) on Hwy 60 toward Nowata, go to County Rd 4340 marker signs there that say Tempson Chapel. Turn right (north) on County Rd 4340 and go 1 mile, turn right (east) on County Rd 250. The field is one mile east of the Country Pets Bed and Breakfast Sign, on the north side of the road.

If there has been heavy rain, **DO NOT TAKE** the low water crossing that GPS frequently uses. Follow the directions above to get to the field in the event of heavy rain.

Coursing is an athletic activity that can tax a dog's physical strength. Dogs that are overweight and/or out of condition may be at greater risk for injury and exhaustion. The inspection committee has the authority to disallow a dog's entry into a test and, in such instances; applicable entry fees will be refunded. Bitches in season, lame and unfit dogs will be excused with entry refunded. Please do not bring bitches in season to the field.

Trial Prizes:

A light blue flat ribbon will be offered for a passing qualifying run. New Title Rosettes will be available for a dog earning a new title.

What is Fast CAT?

Fast CAT is a timed straight 100-yard dash for dogs. Dogs are held at the start line and the coursing lure is activated prompting the dog to follow chasing it to the finish line and into a catch pen. The course is completely fenced and dogs are run individually. Dogs are timed when they complete the 100-yard dash. The time is converted to Miles Per Hour (MPH).

FORMULA: 204.545 / RUN TIME = MPH

Based on the dog's size at the withers, a handicap is applied and points are earned:

- 18" or greater = Handicap is 1.0
- 12" up to less than 18" = Handicap is 1.5.
- Below 12" = Handicap is 2.0.

MPH X HANDICAP = POINTS (ROUNDED TO NEAREST 0.01)

Titles:

Titles are earned at specific point levels and the highest suffix may appear after the dog's name:

- BCAT = 150 points
- DCAT = 500 points
- FCAT = 1,000 points
- FCAT# = each additional 500 points Lure Course

Fast CAT Lure Course Method:

An electronic timing system will be used. An electric, continuous loop, plastic strip lure machine will be used, which means a continuous line passes through the course and the catch pen and then loops back to the start line on the outside of the fenced in area. Electronic timers are used at the start and finish lines. Everyone should stay well back (20') from the course and the lure line to avoid interfering with the lure line and from distracting the participants.

Notice to All Exhibitors:

All exhibitors are responsible for cleaning up after their dogs on the motel, RV and trial grounds. Motels require that dogs be crated when unattended. Any damages to motels, RV sites or the trial site can result in disciplinary action by the Event Committee. It is expected that exhibitors will clean up immediately after their own dogs and strongly encourage others to do the same. All owners/exhibitors should be aware that the entire hotel grounds and RV sites are considered within the trial grounds. You will be responsible for all damage to your room/site and may be subject to disciplinary action in accordance with the rules of the AKC. Any abuse of the grounds will be brought to the attention of the trial-giving club and its Event Committee. Any exhibitor's entries may be refused for previous misuse of the hotel or RV facilities. This is an AKC supported measure.

Test Information:

Dogs should be warmed up before and cooled down after running.

- ALL DOGS RUN AT OWNER'S SOLE RISK
 - Muzzles are allowed to be worn. A lure coursing type/racing jacket is allowed to be worn. Dogs may
 run with a flat collar. (Choke, prong or shock collars are not allowed). No tags or other objects can be
 attached to collar unless they are taped up out of the way.

Flexi-Leads are not allowed to be used near where dogs are running at the ORCA events field.

- All entries must be 12 months of age or older on the day of the test.
- All AKC rules regarding sportsmanship and conduct apply.
- This is a rain-or-shine outdoor event. Please plan accordingly. Bring your own shade, chairs, water and food for you and your dog(s).
- Owners/handlers must clean up after their dogs. No exceptions. Trash containers will be available.
- Keep well away from the FAST CAT course when entering or leaving the course. This is for the protection of your dog and also to avoid distracting dogs that are running the course.
- The trial site is not completely fenced. The FAST CAT course will be fully fenced.
- A porta potty is available
- Dogs must be on lead or crated unless running.
- A \$10 fine will be assessed for any loose dog on the field not competing. If your dog gets loose twice, pack up and leave the field. You will not receive a refund, nor will your dog be allowed to run. A loose dog is a danger to itself and others. Take precautions to keep your dog contained at all times.
- You are responsible for controlling your dog(s) and children. If your dog(s) or children are not under control, you will be asked to leave the field.
 - Any dog exhibiting aggression towards any person will be asked to leave immediately and a refund will be issued. Any dog that cannot be examined by the inspection committee will be excused and a refund will be issued. An aggressive dog form will be filled out and submitted to AKC.
- Each dog requires an entry form for the event in which it is entered.
- Bitches in season and lame dogs will be excused. Entry fees will be refunded.
- The Huntmaster is responsible for field safety and therefore he/she is in complete charge of all dogs and handlers on the field. In service to this responsibility, he/she has the authority to stop the lure in any potentially dangerous situation and signal the handler to retrieve the dog on the course. Listen to the huntmaster and follow their instructions promptly and swiftly.
- Persons exhibiting conduct detrimental to the AKC/ORCA/any dog(s)/other person(s) will be asked to leave the trial site by the Field Committee. A bench committee may be called and the person may be disciplined by the AKC, including a fine and/or suspension. Entry fees will not be refunded.
- No entry fees will be refunded if the event cannot be started or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the club, except at the discretion of the club.
- ORCA members, representatives, volunteers, etc., assume no liability or responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children or spectators before, during, or after this event.

Entries will be refunded for in season or lame dogs only.

- For the safety of the dogs, and as a courtesy to other entrants, a testing dog should have reliable recall. A penalty of up to \$5.00 may be assessed for any dog causing an excessive delay of the event if it cannot be recalled or retrieved from the field, and/or in the event of excessive delay, the dog may be excused for the rest of the event.
- Dogs that delay the event because they cannot be recalled by their owners may be refused entry at future events.

- Any dog that gets loose on the field while another dog is running, the owner will be assessed a \$5.00 penalty fee. If a fight ensues because of the loose dog, the owner of the loose dog will be requested to retrieve their dog and a disqualification form will be filled out and possibility of a bench committee can be called for disciplinary measures.
- Exhibitors should follow their veterinarian's recommendations to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations. If your dog is sick, do not bring them to the field.
