ROLL CALL/INSPECTION: 8:15 a.m.

No wrappings or blankets on dogs prior to inspection.

No Shiny, sparkly blankets. Flexi-leads are not to be used where dogs are running.

ELIGIBLE BREEDS & REGISTRY:

Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco del Etna, Greyhounds, Ibizan Hounds, Italian Greyhounds, Irish Wolfhounds, Pharaoh Hounds, Portuguese Podengo Pequeno, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, and Whippets. All entries shall be individually registered with the AKC or have been granted an ILP/PAL by the AKC.

Effective January 1, 2008: Portuguese Podengo Thai Ridgeback and Sloughis, 1 year of age or older, that have been recorded with the Foundation Stock Service (FSS), or that have been granted and Indefinite Listing Privilege (ILP) are eligible to enter lure coursing tests and trial for junior, senior and master courser titles but are not eligible for championship points, and are not eligible to run in Best in Field.

AWARDS FOR JC TESTS AND TRIAL

Dark green Ribbon for hounds successfully completing Junior Courser test.

First place - blue ribbon;

Second place- Red ribbon;

Third place - yellow ribbon;

Fourth place - White ribbon;

Fifth place - Pink ribbon;

BOB - Purple/gold rosette.

BIF - Red/white & blue rosette.

STAKES OFFERED

Junior Courser Test - Hounds must be one year of age or older.

Qualified Courser Certificate - Hounds must be one year of age or older.

Open Stake - Open to eligible hounds who have one or more of the following titles: a) Qualified Courser certificate, or an **ASFA Field Champion (ASFA Field Champion certificate must be presented with first time entry)**, **CKC Field Champion Certificate**.

Veteran Stake - Any eligible Sighthound that has met certification requirements whose age exceeds six years, except Irish Wolfhounds whose age shall exceed five years, Except, Afghan, RR, Saluki, and Whippets are 7 years.

Specials Stake - Open to all eligible hounds that have earned their AKC FC title. No championship points are awarded from this stake.

Note: Hounds who have received a disqualification at an AKC trial are ineligible to compete until reinstated.

Single Stake - Open to all eligible hounds one year of age or older. QC is not needed. Title points **will not** be awarded from this class. Hound runs alone twice.

RULES & INFORMATION:

All hounds will be checked for breed disqualifications. Altered or neutered hounds may compete.

Monorchid and cryptorchid hounds are **NOT** eligible to compete. Bitches in season and lame hounds will be excused. Hounds not present at the time of roll call will be scratched. Muzzles are not required; it is the owner's responsibility to determine if their hound should be muzzled.

PET VACCINATIONS

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Rabies vaccination should be current, as required for the state you live in.

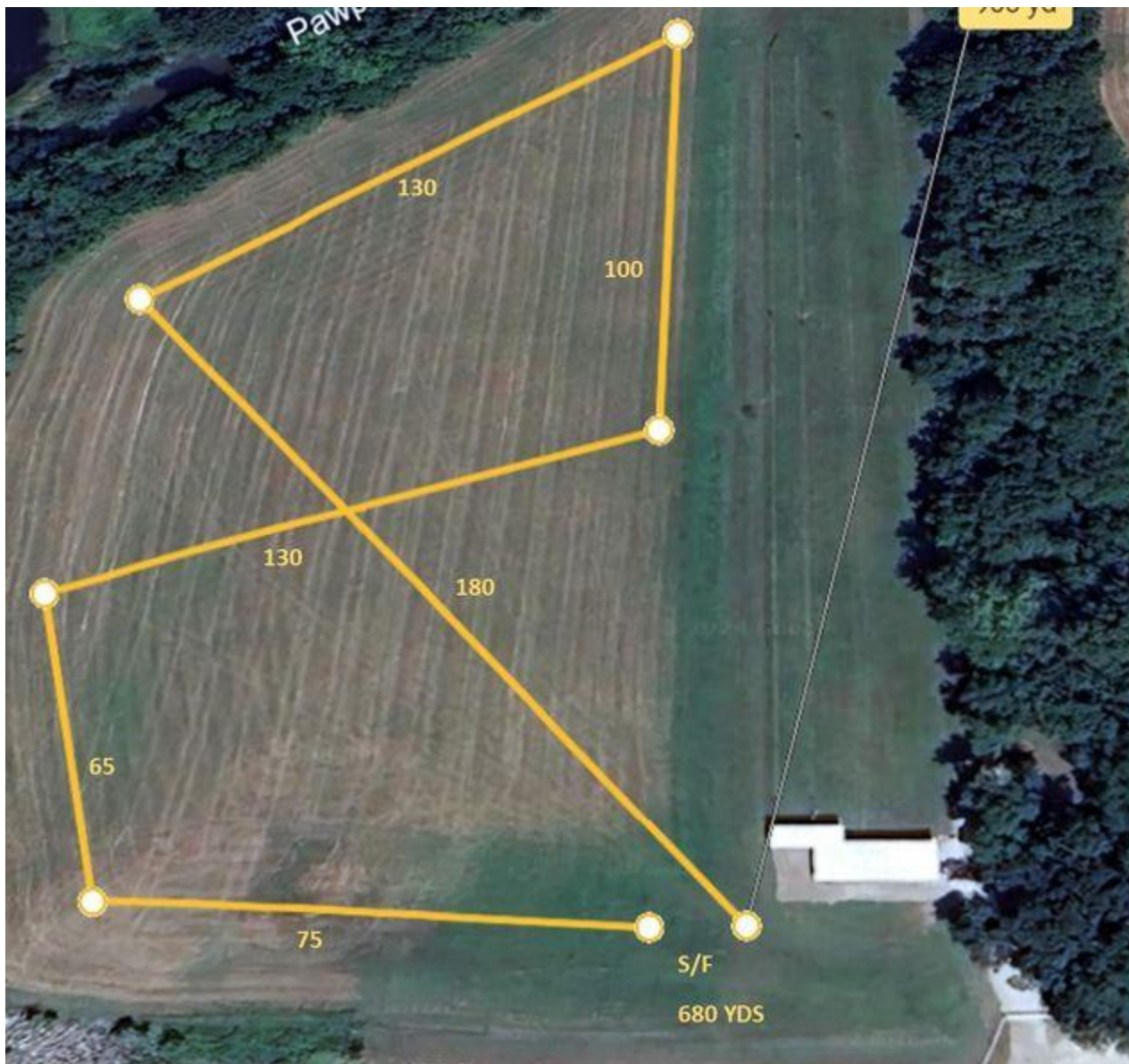

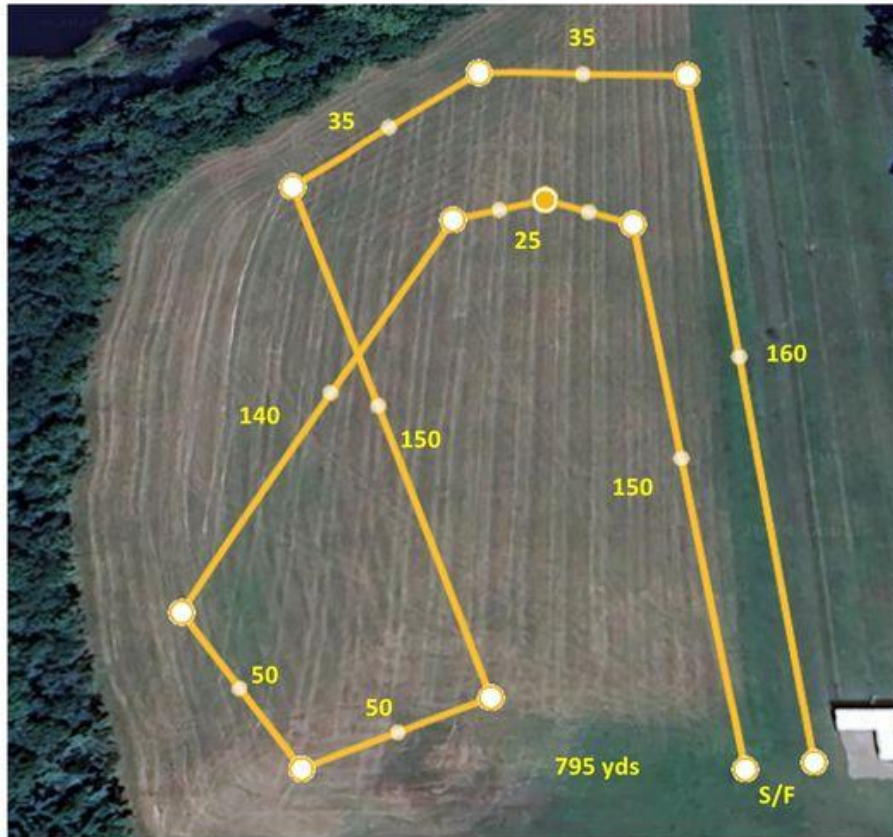

ADDITIONAL INFORMATION:

- ✓ All entries must be one year of age or over on the day of the trial.
- ✓ Bitches in season, hounds with breed disqualifications, or lame hounds will be excused.
- ✓ Hounds not present at roll call will be scratched.
- ✓ Spayed or neutered hounds may be entered.
- ✓ Muzzles are not required. It is the responsibility of the owner to determine if their hound needs to be muzzled.
- ✓ **A fee of \$45.00 will be assessed for any returned checks.**
- ✓ There will be a \$5.00 fine for any loose hound on the field that is not part of the course in progress.
- ✓ Course will be reversed for 2nd run.

- ✓ Persons exhibiting conduct detrimental to AKC/ORCA/any hound(s)/other person(s) will be asked to leave the trial site.
- ✓ Lure machine is battery powered, continuous loop. Back-up equipment is available.
- ✓ The lure will consist of highly visible plastic strips.
- ✓ ORCA reserves the right to alter the course as required by weather and/or field conditions on the day of the trial.
